*to extend the Prevention of Corruption Act, 1947, to the whole of the Province of  
West Pakistan.*

**Preamble.— WHEREAS** it is expedient to extend the Prevention of Corruption Act, 1947, to the whole of the Province of West Pakistan in the manner hereinafter appearing;

**NOW, THEREFORE**, in pursuance of the presidential proclamation of the seventh day of October, 1958, and in exercise of all powers enabling him in that behalf the Governor of West Pakistan is pleased to make and promulgate the following Ordinance:—

- 1. Short title.—** This Ordinance may be called the Prevention of Corruption Act (West Pakistan Extension) Ordinance, 1958.
- 2. Extension of Act II of 1947 to the whole of West Pakistan.—** The Prevention of Corruption Act, 1947, (hereinafter called the said Act), shall extend to the whole of the Province of West Pakistan.
- 3. Amendment of Act II of 1947.—** In the said Act in its application to the Districts of Kalat, Kharan, Mekran and Las Bela references to any provision of the Pakistan Penal Code<sup>2</sup> or the Code of Criminal Procedure, 1898<sup>3</sup>, shall, as far as possible, be deemed to be references to the corresponding provisions of the Tazirat-e-Qalat and Zabata-e-Faujdarī Qalat, as the case may be.
- 4. Repeal.—** The Bahawalpur Prevention of Corruption Act, 1950, is hereby repealed.
