

Special Power of Attorney

I, the undersigned, **Ms. Zainab Bibi, wife of Abdul Hameed**, caste Bhatti, resident of Mohallah Noor Colony, Tehsil and District Chitral, (CNIC No: 00000-0000000-0), being of sound mind and full consciousness, free from any coercion or undue influence, and acting of my own free will and consent, do hereby declare that I am an adult of sound understanding and capable of discerning my own benefit and loss.

The following legal cases involving me are currently pending before various courts:

1. **Zainab Bibi vs. Ali Raza & Others** – Suit for restoration/recovery of possession, pending before the Civil Judge, Lahore, in which I am the plaintiff.
2. **Badaruddin vs. Zainab Bibi** – Suit for specific performance of agreement, pending before the Civil Judge, Lahore, in which I am the defendant.
3. **Zainab Bibi vs. Badaruddin & Others** – Suit/Application for partition of land, pending before the Office of the Tehsildar, Lahore, in which I am the plaintiff/applicant.

As I am a veiled woman and suffer from certain physical ailments that restrict my mobility, I hereby appoint my husband, **Abdul Hameed, son of Ghulam Muhammad**, caste Bhatti, resident of Noor Colony, Chitral (CNIC No: 00000-0000000-0), as my **Special Power of Attorney** holder for the effective conduct and representation in the aforementioned cases.

I hereby grant my Special Attorney the following full and irrevocable powers:

- a) To appear on my behalf in all the aforementioned cases, to file suits/applications, submit written statements and replies, give statements, submit affidavits, present oral and documentary evidence, cross-examine witnesses, enter into compromise or settlement, receive payments, file appeals, revisions, reviews and other related legal proceedings, initiate contempt of court applications, file stay or injunction applications and other relevant motions, engage or replace legal counsel, negotiate and pay legal fees, and obtain receipts thereof.
- b) To obtain, submit, or collect all types of documents and certified copies relevant to court proceedings.
- c) To sign on my behalf wherever my signature is required.
- d) To pursue all legal proceedings at every level from trial courts to the High Court and Supreme Court, including appeals, revisions, reviews, and writ petitions.
- e) I, the undersigned, undertake to ratify and affirm all acts and proceedings carried out by the said Special Attorney and shall be bound by them.
- f) The Special Attorney, being my husband, is fully aware of all circumstances and facts relating to the said cases.
